



## Commercial Exterior Paint Grants Program Overview

**Goal: To help encourage commercial property owners to keep well-maintained and vibrant properties on Wheat Ridge corridors.**

- Program is for mixed use or commercial properties located within the city limits of Wheat Ridge.
- Applications are to include the signature/approval of the owner of the property
- WRBD will provide written approval to an applicant for participation in the program.
- **There will be a maximum reimbursement of \$500 per property and a maximum of 50% match for supply and material costs in paint project.**
- Reimbursement of not more than 50% of the total cost for supplies will be made to the approved applicant within 30 days once receipts for supplies have been received.
- Supplies are defined as paint, brushes, tarps, etc. and will not include the cost for labor.
- Paid receipts are to be provided to the WRBD within 30 days of project completion.
- Participants will have a two month time frame from the date of acceptance to completion of project to be eligible for reimbursement and will be noted on the approved application.
